HIGHWAY IMPROVEMENT SCHEME PROGRESS REPORT

Report of the: West Kent Divisional Manager, Kent Highway Services

Status: For Consideration

Executive Summary: This report describes the progress to date and anticipated progress over the next three months of all remaining programmed highway improvements that formed part of the 2007-08 programme.

This report supports the Key Aim of Reducing speed, encouraging safer driving and tackling known speeding crash hotspots. Also improving pedestrian safety, including measures to improve access for people with disabilities as indicated in the Sevenoaks Community Plan.

Recommendation: It be RESOLVED that:

- 1) That Members note the progress of programmed highway improvements.
- 2) That Members endorse the removal of Otford Lane, Halstead Footway Extension (SEV 3 07/08 in Appendix A) from the approved highway improvements programme.

Background

1. A report on the progress of programmed highway improvements is made to each meeting of this Board.

Discussion

- 2. The planned **carriageway surfacing** programme was completed in December 2007.
- 3. The budget for the planned **pavement resurfacing** programme has been fully spent. Works are nearing completion on the final three roads in the programme (London Road in Sevenoaks and High Street & Fircroft Way in Edenbridge). Resurfacing the pavements in Sevenoaks High Street has been delayed to officers to ensure that utility companies are afforded the maximum opportunity to carry out their works prior to KCC works starting.

- 4. The progress of all **highway improvement schemes** is detailed in the Appendix. Items of note are as follows
 - 4.1 Otford Lane, Halstead - Footway Extension (SEV 3 07/08 in Appendix A). In 2005, Kent Highway Services consulted on the building of a 30-metre length of footway alongside the school in Otford Lane. A weak response led to the proposal being shelved. Nonetheless, because officers considered that it offered an improved walking environment, they included it in the 2006-07 highway improvement However, in the course of outline design, it became apparent in discussions with representatives of the school that the necessary removal of an established hedge to build the path was a significant source of objection. Officers have tried to obtain a categoric statement from the Head Teacher as to whether the school wishes to formerly oppose or support the new footway. Unfortunately, this has To date, officers have not received any not been forthcoming. indication from the school that it considers the path necessary or even In the absence of this, officers recommend desirable. proposal be formally withdrawn from the programme
 - 4.2 Hildenborough Road, Leigh New footway (SEV 6 in Appendix A). After works had started on site, officers were alerted an adjacent landowner had long-ago registered the land on which the path was being built. Although Kent County Council records it as forming part of the highway, the evidence was not sufficiently robust to justify the works continuing. Accordingly, works have been postponed whilst negotiations are undertaken with those who have registered the land. It is not possible to say when these negotiations will be complete or what the outcome is likely to be. If the outcome necessitates a significant variation to the proposal agreed by this Board, a further report will be made before work recommences.
 - 4.3 Childsbridge Lane, Seal Speed Management (SEV 7 in Appendix A). Officers have been unable to prepare a design that fulfils the local criteria, the available budget and design codes of practice in time to assure Members of what can be built and when. Significant redesign is required and this, in turn, will need to be consulted upon. This means that the revised proposal must, in time, be reassessed under the PIPKIN priority assessment system approved by the County Council's Highways Advisory Board. A more detailed update will be provided to Members at he next meeting of this Board.
 - 4.4 Station Road, Shoreham New footway between the village and Shoreham railway station (SEV 18 in Appendix A). Under the PIPKIN priority assessment system approved by the County Council's Highways Advisory Board, the proposed footway between Shoreham Station and the village has failed to attain sufficient priority to attract funding in 2008-09. The outline design has therefore not progressed beyond the conceptual stage reported to the last meeting of this Board. Prior to the next meeting of this Board, Officers will explore any other sources of funding that would enable this project to come to fruition.
