

- Restriction in the number of qualifications that count (3,000 qualifications removed)
- Broader application of discounting rules across qualification types (GCSE / BTEC and vice versa)
- Removal of speaking and listening component from GCSE English examinations (not iGCSE/certificates)
- No qualification can count as larger than one GCSE
- Only 2 non-GCSEs can be included per pupil in all measures
- With effect from 29 September 2013, only a student's first entry to a GCSE examination will count in their school's performance tables.
- Move to linear GCSE format all assessments are to be undertaken at the end of the course

#### **Basic Need**

- Under the Basic Need capital grant allocation, Kent has 3 phases running until 2015/16. Phase 1 (delivery Sep 13) 35 expansions; Phase 2 (delivery Sep 14) 30 expansions; Phase 3 (delivery Sep 15) 6 expansions, 2 expansion/ relocations, 6 new schools. We will also be working on/ expanding 10 Special Schools
- Kent was allocated £39m for the 2013-15 funding period, but only £27m for 2015-17. This will not be sufficient funding to create the required places. Correspondence with Ministers, lobbying for a fairer allocation, has been on-going since January 2014.
- KCC were successful in a bid for Targeted Basic Need in July 2013 and received £31m for 19 schools (delivery Sep 2015).

#### **Sevenoaks Grammar School - Timeline**

- March 2012 County Council vote to agree a Grammar annex in Sevenoaks
- Spring 2013 Agreement for Trinity Free School and Grammar Annex to share the former Wildernesse site
- July 2013 Submissions by Weald of Kent and Valley Invicta Academy Trust to Secretary of State
- December 2013 Michael Gove rejects both bids
- Spring 2014 After consultation, Weald of Kent drops proposal for a co-ed grammar annexe
- July 2014 KCC planning application approved to build the annex
- November 2014 Weald of Kent submit a single sex Annex bid to Secretary of State
- November 2014 Contractors on site for demolition
- April 2015 Main construction works begin
- Autumn 2015 Trinity Free School to be on site
- Autumn 2016 Proposed opening of girls Grammar Annex



# **School Transport**

- Two years ago, the transport to school policy changed.
- Children must attend their nearest school and live more than the statutory distance from their home to be eligible for transport.
- For low income families the statutory distance is 2 6 miles to any one of their 3 nearest preferred schools. Transport would be granted to their nearest schools (of any type)
- The Young Persons Travel Pass costs £200 per year and provides transport from Monday to Fridays between 6am and 7pm. This replaces the Freedom Pass which cost £100. KCC has had to balance the desire to support parents exercising choice, with the fact that it is no longer affordable for Local Authorities to provide wide reaching discretionary transport to particular types of schools. It remains a heavily subsidised, discretionary service.
