Reason for Decision

All Members were consulted and given full details of the proposed new models. Details of the proposed models and how they affect Sevenoaks District were also taken to the Health Liaison Board on 25 November 2015.

The consultations seek views regarding new service delivery models with Kent Public Health. Responses will be used to improve and redesign services around the needs of residents.
