KCC's vision and strategy for adult social care for the next five years has identifies the crucial role the District Council has in helping to deliver the ambitions of the strategy. Given reduced funding and the commissioning outcomes based models proposed in the document, it is not clear whether these increased expectations will be accompanied by increases in funding.

This includes of the health prevention agenda with acknowledgement of the role district councils have to play in this. In this context, the implications of the strategy that seeks to integrating health and social care should be viewed alongside discussions in the closely related West Kent Public Health Preventative Services devolution model.
