Subject: Sevenoaks District Better Care Grant

Details of Decision taken

To agree the guidelines and application form for the Sevenoaks District Better Care Grant.

Reason for Decision

The Government's Better Care Fund has been introduced to facilitate integration between health and care to improve the health of local populations and make more efficient use of resources. As part of the Better Care Fund, the Government has allocated £0.431 billion for Disabled Facilities Grants.

Sevenoaks District Council was awarded £976,757 for 2017/18 from the Better Care Fund for Disabled Facilities Grants and other initiatives. The Council spends this money by awarding grants to disabled people to enable or restore independent living for them and their families. However, in December 2017, the Council was awarded an additional £ 100K from the Better Care Fund, which it needs to spend before March 31 2018.

In addition to delivering the Disabled Facility Grants, the Council is setting up the Sevenoaks District Better Care Grant to offer funding to facilitate innovation in the way preventative and other projects help older people, those with long term conditions or disabilities stay well, manage their conditions better or recover from illness or injury.

Funding allocated to the Sevenoaks District Better Care Grant is £100K. This funding needs to be paid out before 31 March 2018, so Portfolio Holder agreement is sought so that the grants can be advertised as a matter of urgency.
