#### Introduction

The Sevenoaks District Better Care Grant (SDBCG) encourages Sevenoaks District Council to think strategically about the use within the private sector of home adaptations, technologies to support people to live independently in their own homes for longer and to take a joined-up approach to improving outcomes across health, social care and housing.

The NHS and Social Care provides 24 hour high quality treatment and care. However, some of the additional demands, especially during the winter months, are preventable with early and directed interventions.

The SDBCG would like to improve the way the housing related element of such services is offered and integrate health services, social care, the voluntary sector and Sevenoaks District Council. Better integration between these services will reduce unnecessary demands for both primary and secondary care and improve the wellbeing of our residents. Funding is now able to facilitate innovation in the way preventative and other projects help older people, people with long term conditions and people with disabilities stay well, manage their conditions better or recover from illness or injury.

We would like to see applications for innovative projects working with local people that will identify and reduce avoidable health and social costs associated with housing related issues. By resolving such issues, the health and wellbeing of residents is improved and cost savings are achieved by health and social care providers.

All projects must show how they will increase applications for the financial assistance available via the 2017 Housing Assistance Policy.

Please note that we cannot fund existing services - this funding is for services and projects in addition to those already in place.

### What are the scheme's priorities?

We want to see applications that deliver one or more of the primary aims:

- Reduce or eliminate by preventative actions hospital/GP admissions because of housing related issues;
- Consider the long term needs of individuals and reductions in associated treatment and social care costs:
- Undertake works, adaptions or provision of equipment that is not provided by any other service; and
- Where possible, also achieve the secondary aim of allowing speedier discharges from hospital.



### What sort of outcomes are expected from the funding?

We expect projects funded to achieve one or more of the following outcomes:

- Increased use of discretionary and mandatory assistance provided via the Housing Assistance Policy 2017;
- Use of technologies to support people to live independently in their own home for longer;
- Reduced demand placed upon GP resources (reduced calls or medication);
- Supported independence and reduce risks within the home;
- Reduced emergency admissions and unplanned surgery;
- Reduced sense of loneliness or isolation;
- Improved mental health;
- Developed services in response to local need;

We expect applications to work with groups of Sevenoaks District residents either in their homes or in community settings.

All grants funded must achieve one or more of the scheme's primary priorities and one or more of the outcomes above.

### Who can apply?

You can apply if your organisation is one of the following:

- Registered charity;
- Health organisation;
- Voluntary organisation;
- Community Interest Company.

We welcome partnership applications from two or more organisations working together but the lead organisation will be responsible for the delivery of the project.

If your organisation works with children, young people or vulnerable adults, you should have a Safeguarding Policy and staff and volunteers must have enhanced level Disclosure & Barring Service checks and appropriate training.

### How much and for what can I apply?

The most we will award for any one application is £40,000.

The grant can be spent on project costs including, but not limited to:

- Support for older people;
- Support for people with disabilities;
- Support for people with long term illnesses;
- Equipment;
- Transport costs;
- Premises hire;
- Management costs;
- Staff and volunteer costs.



#### **Terms and Conditions**

By applying, you are confirming that you comply with the terms and conditions. The main conditions include:

- Your organisation has a constitution;
- Your organisation has a bank account with at least two authorised signatories;
- Your organisation has an equalities policy in place and is prepared to sign our Equalities Statement;
- All appropriate legal agreements, insurances and processes needed to deliver the project are in place;
- Health and safety risk assessement including a lone working policy and safeguarding arrangements for children and vulnerable adults;
- Any grant you are awarded will be used only for the project set out in your application and will be ring-fenced to help Sevenoaks District residents. It must not be used for any other purpose;
- You will be required to submit monitoring for your project with supporting evidence;
- All publicity materials and annual reports must acknowledge our support;
- Your organisation can only submit one application in any financial year;
- Any grant unspent will be refunded to Sevenoaks District Council.

### **Grant Evaluation Timetable**

Applications can be submitted any time up to 28 February 2018 by post or in person to:

- We will confirm receipt of all applications within three days.
- Applications will then be appraised by a team of officers who will make recommendations to Council Members, who will then make the final decision on funding.
- Your application will be appraised against the grant guidelines and we will evaluate the extent to which you meet the priorities and outcomes of the grant.
- All grants awarded will be paid out by 31 March 2018 and organisations receiving funding will have 12 months to deliver their project.
