More specifically, we will monitor your progress against the following:

#### **Approved Purposes**

- High visibility acknowledgement of the National Lottery funding awarded by the Heritage Lottery Fund on site, online and in all activities
- Develop and deliver a plan for how you will use your project to thank National Lottery players for their support
- Carry out capital repair and refurbishment works to Bat & Ball Station, to create hireable venue space, a café and other facilities.
- Deliver an activity programme as detailed in your second round application, to include:
- the recruitment of a Heritage Engagement Officer
- a range of events and activities
- a schools education programme
- three building apprenticeships and other accredited construction training opportunities
- permanent onsite interpretation
- Establish a directly managed café, Kentish produce retail and venue hire business in the refurbished station.
- Produce a project evaluation.

#### **Dear Board Members**

#### Re: Improved Infrastructure at Bat & Ball Station

Please take this letter as confirmation on behalf of Sevenoaks Town Council that it fully supports the application for Community Infrastructure Levy funding towards the Improved Infrastructure at Bat and Ball Station.

Sevenoaks Town Council has set out some ambitious plans for the regeneration of the Bat & Ball area extending across the Northern Ward. To date the Town Council has funded its projects from its own funds. However as the ambitions grow so does the project budgets.

There are five projects within the proposal for the Improved Infrastructure at Bat & Ball Station set out in the funding application:

- 1. Refurbishment of the Bat & Ball Station building.
- 2. Provision of new direct access to Platform 1
- 3. Provision of cycle racks adjacent to Platform 1
- 4. Provision of cycle racks adjacent to Platform 2
- 5. New access route from Bat & Ball Station to Otford Rd, via community centre site

The refurbishment of the Bat & Ball Station building has been a direct response to the local public who have been concerned about the condition of the building, its surrounds and the perceived community safety issues, particularly for students attending the nearby three secondary schools. The Town Council has consulted extensively on the project and received considerable support. It is currently at a Stage 2 Heritage Lottery Fund application and it hoped that by the time your board meets there will be some positive news.

In these times it is difficult to understand that there is still a station which you cannot use if you have mobility problems or are a parent with a child in a buggy. The proposal to open up Platform 1 from the community centre will provide a solution to this issue and I know it is eagerly awaited by many.

#### RE: Sevenoaks Town Council Application for Funding, Bat & Ball Station

I am writing in support of the Sevenoaks Town Council's application for funding to improve transport infrastructure at Bat & Ball Station.

The Northern Sevenoaks area has already undergone significant development. Consequently, Bat & Ball Station has experienced a considerable rise in demand.

To meet this increasing demand, Bat & Ball Station requires infrastructure improvements. In particular, the Station will need refurbishing and access to the platform must be improved for those with mobility restrictions and pushchairs.

With the development of our new grammar annexe and the expansion of Trinity School on the former Wildernesse site, the number of students using the Bat & Ball Station in peak hours will increase. Pedestrian, bicycle and vehicular access to the station is therefore crucial, so the station will require cycle racks on both platforms, as well as access from Otford Road via the Community Centre.
