Conclusion

Watling Tyres have the lowest price submitted in this tender as they do not quote for all michelin or other primary brand, and subsequently the brand quoted is not a primary brand of tyre and given the use of these tyres in our experience will cost SDC more over the life of this contract. On account of this they have been marked down on the tender value scoring for quality and specification.

ATS have come in slightly more expensive than Watling but cheaper than PK Commercial, however PK Commercial Tyres have a better tender response, a proven track record and quality service with SDC. Additionally, historically, in our experience ATS have had a poor response time to maintain our fleet whereas PK Commercial work with us to provide a good service supporting our workshop and fleet and were both marked accordingly for this under the assessed capability to support the contract. It is therefore our conclusion, given the marginal price variations between the tenderers over a year of the contract, that PK Commercial Tyres be awarded the EU contract.
