





I refer to the requested extension of closing hours for Istanbul Kebab, 42 High Street, Edenbridge, Kent and would comment as follows:

In my opinion, extending the current Friday and Saturday opening hours from 12pm to lam is unnecessary and inappropriate in what is now an increasingly residential area.



I do not see that the additional hour will help in any way to relieve the aggravation caused by latecomers; if anything, it will only exacerbate and prolong existing disturbance.

If, however, the decision is made to extend the licence, I would be grateful for some assurance that it will be enforced. From my experience with previous owners, who have repeatedly opened until well past their licensed hours, little has been done to regulate this.
