My cottage is located next to the delivery yard for the store and also I am located close to the High Street where trading will take place.

I object to the opening (and licencing) hours for the store as it is inappropriate to the needs of the community and will create anti-social behaviour.

Prevention of Crime: We have no resident police presence so any irresponsible drinking cannot be dealt with quickly.

Promoting Public Safety: Drink purchased from a supermarket can generate drinking in public and cause a danger to the public.

Prevention of public nuisance: There are already two off licences in the High Street and a Co-operative store selling alcohol. There is no need for another outlet and this proposal is for opening hours in excess of other stores who are aware that longer opening is not needed.

Protection of children from harm: Hopefully no alcohol would be sold to children but it is still possible for others to purchase it and then give it to children.

Regarding deliveries: The delivery yard is just outside my (and other cotagers) bedroom window. The arrangement with Somerfields was for 7.30am to 7.30pm Mon to Sat and no deliveries to the yard on Sunday. This worked for the past 20 odd years and is quite sufficient for stocking the store. I am unable to get in contact with the relevant person at Tesco to set up this arrangement with them so am likely to be making an objective to noise generated in the yard when the store opens. I trust that I will be supported as any new store needs to work with the community and not only in their own interests.
