Recommendation: It be RESOLVED that the proposed amendments to the Contract Procedure Rules (contained in the Appendix) be approved and that the Constitution be amended accordingly.

Introduction

The European procurement thresholds, which dictate when a contract of a certain value has to be published in the Official Journal of the European Union, were revised on 1 January 2010. As a result, some of the figures contained within the Council's Contract Procedure Rules are now out of date and need to be amended. The Council's Financial Procedure Rules are not affected, as they simply refer to purchases "at the EU Procurement Limit and above", rather than specifying the figure.

Proposed Amendment to Contract Procedure Rules

- It is proposed that the Contract Procedure Rules be amended by deleting references to any specific amounts and replacing them with the generic phrase, "EU procurement threshold". This would bring the Contract Procedure Rules in line with the Financial Procedure Rules and would mean that an amendment to the Constitution would not be required each time the European Union adjusts the thresholds. The Contract Procedure Rules require responsible officers to seek advice on the appropriate limit from the Council's Audit and Legal teams.
- The proposed amendments to the Council's Contract Procedure Rules are shown in track changes in the Appendix.
