Actions from meeting of the Finance Advisory Group - 23 April 2013

Action 1: New Legislation effective 30 May 2013

We received 59 applications in 12/13 for 'single storey rear extensions' generating approx. £10k income.

Our current consultation process requires us to consult those properties which share a boundary with the application site so this would normally be 3 neighbours minimum (1 each side and 1 to the rear), this will also apply to dealing with 'applications' (notifications) received under the new procedure. We will also have to copy this correspondence to the applicant. I would estimate printing and postage at roughly $\pounds 5$ -10 per app. as we may also need to print site notices.

We intend to deal with these applications electronically and email the acknowledgement and decision. Officers will not be given a paper copy of the application, they will have to use IDOX. This is intended to offset the cost of dealing with additional applications where no fee is payable.

We have been ready since 30 May to deal with applications despite being given very short notice.

So far we have received 2 notifications under the new legislation.

Action 2: Appeals

Cases in 12/13 where a member overturn was appealed and allowed are;

Costs were not applied for by the appellant. In all these cases the Council would have been able to submit information to the Inspectorate to support the decision to refuse the application.

As discussed if a householder application is refused and then appealed we are not able to submit further evidence to the Inspectorate.
