- 15 Traffic Marshals
- 1 Paramedic and 1 Medic
- Age verification ID checks at bars



PUBLIC SAFETY

- Security team of 6
- Health and safety team of 4 to monitor potential alcohol misuse
- Lake supervised at all times
- Traffic disruption minimised - park and ride facility
- Terror threat & fire evacuation procedures in place
- Designated fire assembly points



PREVENTION OF PUBLIC NUISANCE

- Professional sound engineers monitoring sound levels
- 25 min breaks between acts on the main stage to ensure continuity of acceptable sound levels
- Strict zero tolerance policy on drug and excessive alcohol misuse
- 9pm finish on Saturday and 6pm on Sunday



PROTECTION OF CHILDREN FROM HARM

- Clearly signposted designated lost children area with DBS checked staff in attendance.
- Parent /Guardian mobile contact numbers noted on all children's wristbands.
- Professional DBS (CBR) checked security.
