**PROCEDURE AT HEARINGS OF SUB-COMMITTEES OF THE
LICENSING COMMITTEE ESTABLISHED IN ACCORDANCE WITH
SECTION 9 OF THE LICENSING ACT 2003**

1. In accordance with Section 9 (1) of the Licensing Act 2003, the Licensing Committee has resolved to establish one or more Sub-Committees each consisting of three members of the Committee.
2. The Sub-Committees have delegated authority to determine those functions that are reserved for decision by the Sub-Committees in accordance with Appendix B of the Council's Statement of Licensing Policy dated 7 January 2005.
3. Hearings shall be conducted in accordance with this Procedure Note and The Licensing Act 2003 (Hearings) Regulations 2005 subject to the right of the Sub-Committee to vary that procedure at their absolute discretion if considered in the public interest.
4. The quorum for a hearing of a Sub-Committee shall be three members.
5. At the commencement of each hearing the Sub-Committee shall elect one of its members as Chairman.
6. The order of business at hearings shall be:
 - (a) Election of Chairman
 - (b) Declarations of interests
 - (c) Chairman explains the procedure to be followed at the hearing, including the setting of equal time limits for all parties and the granting of adjournments.
 - (d) Chairman ascertains who is assisting or representing the parties.
 - (e) Applicant (or his/her representative) addresses the Sub-Committee
 - (f) Applicant questioned by members. At the discretion of the Sub-Committee, other parties may be permitted to question the Applicant.
 - (g) Persons who have made representations in respect of the application (or their representative) address the Sub-Committee. No issues other than those relevant to their representations may be raised.
 - (h) Members question each party at the conclusion of their address. At the discretion of the Sub-Committee, the Applicant may be permitted to question other parties.
 - (i) Sub-Committee may offer the parties a short adjournment to discuss in the absence of the Sub-Committee whether a solution acceptable to all the parties can be put to the Sub-Committee.
 - (j) Applicant (or his/her representative) makes closing address.

- (k) Sub-Committee may grant a short adjournment. The parties may not speak to members regarding the application during adjournments.
- (l) The Sub-Committee considers the application and motions put to accept or reject the application in the terms requested or to grant the application subject to specified conditions. Reasons are to be given for motions.
- (m) The parties will be informed of the decision at the hearing or thereafter in accordance with Regulation 26 of the 2005 Regulations.

Background

- 1 The procedure for Hearings of Sub-Committees of the Licensing Committee established in accordance with Section 9 of the Licensing Act 2003 is attached at Appendix A.
- 2 The application is made by Edenbridge Rugby Football Club, The Pavilion And Recreation Ground, Lingfield Road, Edenbridge, Kent. TN8 5DY) The playing of Rugby Union and other organised sports such as football.
- 3 Purpose built, brick elevations, sheet metal roof, 2 car parks, 90 spaces. residential area behind, sports fields to front and sides. Internal social area including bar, kitchen, storage area, cellar, changing rooms and showers, toilets. Security locks, monitored intruder/fire alarms. Security and emergency lighting. Disabled access. Access from Combe field and Lingfield Road.
- 4 The club also extends to the recreation ground as per plans.

The application is to:

Section E	To allow live music indoors on Monday to Saturday from 10:00 hours until 00:00 hours and on Sunday from 11:00 hours until 23:00 hours.
Section F	To allow recorded music indoors on Monday to Saturday from 10:00 hours until 00:00 hours and on Sunday from 11:00 hours until 23:00 hours.
Section H	To allow anything of a similar description to that falling within (e), (f) or (g) music indoors on Monday to Saturday from 10:00 hours until 00:00 hours and on Sunday from 11:00 hours until 23:00 hours.
Section I	To allow the provision of facilities for making music indoors on Monday to Saturday from 10:00 hours until 00:00 hours and on Sunday from 11:00 hours until 23:00 hours.
Section J	To allow the provision of facilities for dancing indoors on Monday to Saturday from 10:00 hours until 00:00 hours and on Sunday from 11:00 hours until 23:00 hours.
Section L	To allow sale of alcohol for consumption on the premises on Monday to Saturday from 10:00 hours until 00:00 hours and on Sunday from 11:00 hours until 23:00 hours.
Section M	Hours premises are open to the public on Monday to Saturday from 08:00 hours until 02:00 hours and on Sunday from 08:00 hours until 00:00 hours.

The applicant intends to take the following action in order to promote the four licensing objectives if the proposed variation/application (delete as appropriate) is granted:

General

- 5 On site supervision by management committee and official of member club. Membership restricted to bona fide sports clubs with other members at discretion of membership committee

The Prevention of Crime and Disorder

- 6 Members of management committee must be on premises when bar is open. Use of trading standards guidance notes. Training manual. Proof of age is required (photo type driving licence or citizenship card). Town Council provide and empty litter bins outside. Provision of external lighting. Bar is restricted to

members and their guests, visiting teams and their supporters. Active encouragement of responsible behaviour

Public Safety

- 7 Bar staff act as fire wardens. Fire exits, signs, emergency lighting and fire extinguishers. Hours of operation limited by sporting events/members demand i.e. during/after matches. Active encouragement of responsible behaviour.

The Prevention of Public Nuisance

- 8 Member clubs events observe licensing hours. At the end of any event members will be asked to leave quietly so not to disturb surrounding residents

The Protection of Children from Harm

- 9 Children under 16 are permitted in social area where licensed bar is located. Children are normally supervised by parents or relevant club official, bar staff would provide back up for this. A minimum standard of behaviour is enforced in the social area.

- 12 Mandatory conditions – the following conditions will be added to the club premises certificate when it is issued.
- 13 Supply of alcohol for consumption off the premises - A club premises certificate may not authorise the supply of alcohol for consumption off the premises unless it also authorises the supply of alcohol to a member of the club for consumption on those premises.
- 14 A club premises certificate which authorises the supply of alcohol for consumption off the premises must include the following conditions:-
- 15 the supply of alcohol must be made at a time when the premises are open for the purposes of supplying alcohol, in accordance with the club premises certificate, to members of the club for consumption on the premises.
- 16 Any alcohol supplied for consumption off the premises must be in a sealed container.
- 17 Any supply of alcohol for consumption off the premises must be made to a member of the club in person.
- 18 The decision is to be made with regard to the Licensing Act 2003, Secretary of State's Guidance issued under Section 182 of the Act and the Council's Statement of Licensing Policy. Where the decision departs from the Policy or Guidance the departure must be directed solely at the attainment of the licensing objectives, and such departure must be supported by clear and cogent reasons.

- 19 This Hearing is regulated by The Licensing Act 2003 (Hearings) Regulations 2005 No. 44.
- 20 The decision of this Hearing will be encompassed within the issued premises licence, and the licence will take effect on the 10th June 2011, subject to any appeal to a Magistrates Court or higher Court.

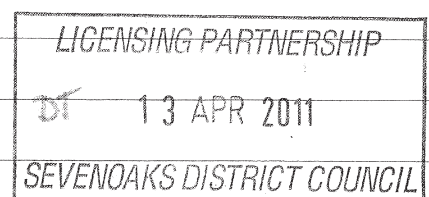

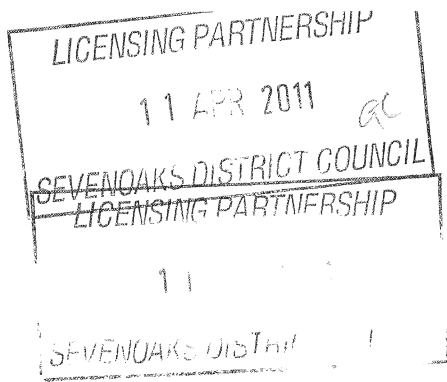

Re: Application by the Edenbridge Rugby Club Licensing Application

I wish to register an objection to this licensing request from the Edenbridge Rugby Club as posted on the premises at the Edenbridge recreational ground facility.

The car parking facilities are already too small for the number of members of this club, as residence we are often subjected to abusive language when we ask visiting teams/families to move on from the frontage of our homes. We also have to suffer the problem of access to and from Coomb Field as some residence park as per their right, on the public highway thus making it difficult for residence to leave Coomb Field as they encounter a flow of traffic coming the opposite way to the playing fields.

I believe it is also fair to state that BT had to replace a manhole cover after one individual parked their 4 x 4 on an access cover and it crumbled under the weight of the vehicle. Most players and visitors see the pavements as an extension to the road for parking. I should also mention that BT did leave the manhole cover for sometime before replacing it, putting the health of young children who play in the area at risk and this was down to the fact that there is insufficient room in the car park for both members and visitors.

Already we have to put up with anti social behavior from the Rugby club who on practice nights, sometimes go behind the sea container backing onto our boundary fence and use this area as a urinal.

The young Families, particular those that overlook the playing fields should be considered in that additional noise and disturbance would be detrimental to their health if drinking goes on till 2 am in the morning.

Lastly I feel I should also make my own position clear. Firstly my wife has Cancer (for 3 years now) and does not sleep well particularly when she has had a chemo infusion at the hospital, then suffers sleeplessness due to the fact she has a secondary infusion devise attached to her for 46 hours.

I have to work up in London now and often in bed by 09:00 - 09:30 during the week as I have to be up around 05:30 to catch trains. I have no choice in this as this is where the NHS has work for me. When the summer really starts and we have windows open at night like most of the residence close to the club, how would we manage to avoid being disturbed?

In summery the granting of a license for additional Monday to Saturday activities by the Edenbridge Rugby club would have an impact on the local residence by seeing an increase in unsocial parking as the official car park fills up. Also I do not wish myself to be subjected to male urine smell during the coming summer as has happened in the past. My wife indeed does need to be outside relaxing and having an odious smell drifting around the small garden where she like to spend her time. Also should be considered the additional vehicle and noise and pollution on the health of the residence of Coomb Field...

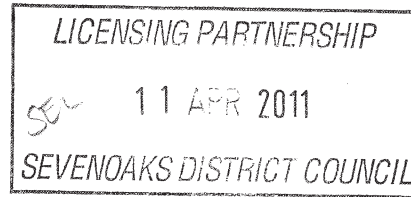

**EDENBRIDGE RUGBY CLUB LICENSING APPLICATION –
 AN OBJECTION**

I feel it appropriate to object to the subject licensing application in the strongest possible terms – in short because I feel that introducing the virtually unrestricted sale of alcohol will exacerbate an already unpleasant environment that the residents of the Coomb Field area have to tolerate. This unpleasant environment is, largely, I regret to say as a result of local government - at both District and Town level - walking away from a known problem. A problem that is totally and utterly un-policed, uniformed or otherwise. And that is said by someone who has two sons, both of whom are police officers!

As a long term resident (since 1989) of Coomb Field I have seen a steady erosion of the local environment by the noisy and ungracious behaviour (made worse by inconsiderate parking) of users of the sports ground during daylight hours at weekends throughout the entire year. More intrusively, however, has been the use by young local people in the evenings and nights of the spring, summer and autumn months. At such times residents are unable to use their gardens for relaxation as a result of having to put up with the noisy, screeching car and motorcycle racing that takes place - particularly in the Lingfield Road car park. As the evening/night wears on and having grown tired of destroying their tyres and engines, this becomes coupled with equally noisy and provocative personal behaviour. The local police (if there is such a thing) seem totally disinterested and incapable of preventing, reacting to or even understanding such behaviour. The next morning, as the local ground staff will be able to confirm, the whole area can end up covered in bottles, cans, take away cartons and other debris.

Add to this the fuel of alcohol from an unregulated rugby club throughout half the night and I can foresee the situation getting much, much worse - with absolutely no control being exercised in any way whatsoever. In short we could well see our evening and night-time environment being turned into hell – particularly so at weekends. I would suggest that there are already enough outlets selling alcohol in the town of Edenbridge - all within a very short distance from the club - without adding yet another.

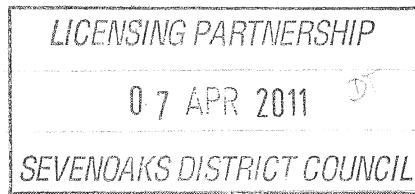
Not only that, there are young children, many of school age, living in the Coomb Field area whose well being is the stuff of your and my future. Some live in houses backing directly onto the club house – others live in houses backing on to the Lingfield Road car park. They need undisturbed sleep from early in the evening until breakfast time!

Finally I would remind you that the club is there to support the sporting activity of rugby- with all that means with regard to health and well-being. It should not be an excuse for a “piss-up”! Having been a rugby player myself, albeit in the days when there was respect for your neighbours (not something today’s young people even think of), I know only too well how pre (for the followers) and post match (for everyone) drinking can lead to behaviour that gets completely out of hand.

Should you decide in favour of the application then I can assure you that, in concert with others in the Coomb Field area, I shall pursue the matter of reversal with considerable vigour and fortitude – perhaps beginning with our Member of Parliament, the Right Honourable Sir John Stanley.

I look forward to hearing what action you intend to take.

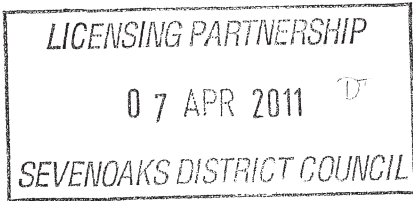



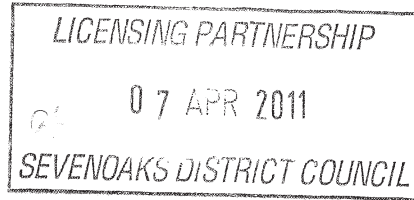

I have recently been made aware of a licence application by Edenbridge Rugby Club for an alcohol and entertainment license at the premises at the Lingfield Road Sports Pavilion in Coomb Field, Edenbridge.

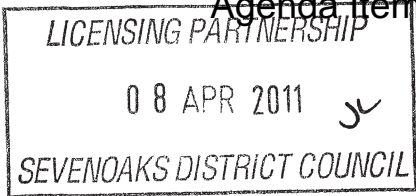
My main concern with this application is the noise pollution it will create. To have the potential for the premises to be open seven days a week until 2 am Monday to Saturday and 11pm on Sunday, serving alcohol up until midnight and 11pm respectively means that patrons to the premises will be leaving the club in the early hours, through a small private housing estate, and in high spirits.

On the occasions when the premises are used for parties and events, we experience noise disturbance in the early hours, but as this is not a regular event, we accept it as part of living in close proximity to the recreation ground and facilities. However, to actively encourage this type of event on a regular basis, in order to make the premises more cost effective, and extending the existing opening times of the premises will cause misery for the residents, many of whom have small children.

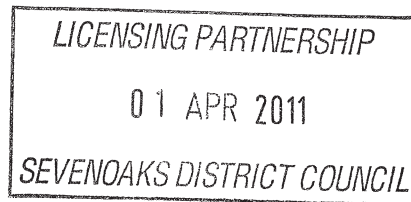

As local residents, we write to make an objection to part of the rugby club application. We are opposed to the premises being licensed to serve alcohol until midnight Monday – Saturday and being open until 02:00hrs.

Our property backs on to the car park area. We have a daughter under one year old who sleeps in a bedroom to the rear and we feel that there is a strong likelihood that there will be increased noise and disruption into the early hours of the morning, particularly if the premises are open until 02:00hrs and music is being played. Patrons will be drinking alcohol which brings with it associated problems of louder conversations and persons under the influence of alcohol more likely to behave in an anti social manner.
