- 1.2 The Sub-Committees have delegated authority to determine those functions that are reserved for decision by the Sub-Committees in accordance with Appendix B of the Council's Statement of Licensing Policy dated 7 January 2011.
- 1.3 Hearings shall be conducted in accordance with this Procedure Note and The Licensing Act 2003 (Hearings) Regulations 2005 subject to the right of the Sub-Committee to vary that procedure at their absolute discretion if considered in the public interest.
- 1.4 The quorum for a Sub-Committee shall be two members.

Mandatory conditions – the following conditions will be added to the premises licence when it is issued.

Door supervision

Any premises which includes a condition that door supervisors must be at the premises to carry out a security activity, shall ensure that each such person is licensed to conduct such activities by the Security Industry Authority.

The decision is to be made with regard to the Licensing Act 2003, Secretary of State's Guidance issued under Section 182 of the Act and the Council's Statement of Licensing Policy. Where the decision departs from the Policy or Guidance the departure must be directed solely at the attainment of the licensing objectives, and such departure must be supported by clear and cogent reasons.

Dear Jessica

I note with some concern that Eureka has applied for an entertainments licence and that within this application they have shared that there are no residences within 1km, this is wholly inaccurate. As the nearest resident and village councillor I am concerned about this application, and wish to comment and make objections on behalf of myself and my neighbours that I have been able to speak to, who have also voiced great concerns and objections to me.

I have listed below the properties that are within 500m and 1km of this club and would also like to point out that the club is on one side of a beautiful tranquil rural valley, where many young families live. I have fielded many complaints about the noise from the club over the years form residents, and of the revellers at this club roaming further than just the club, i.e. sleeping on our land, and entering peoples property.

The noise has been on many occasions outrageous, the most recent being an open to the public, (even though it is supposed to be a private members club) custom car show on August the 12th. The noise was so great that the horses owned by my family in the field adjacent to the club had to be taken out of the field and stabled to try to calm them down. We and our neighbours, on this day and others, were and are continually disturbed by members of the public trying to find the club. Our family members have also been subjected to members of Eureka club observing them from the woods within the Eureka land, with no cloths on, and as I have 3 young teenage children, I hope you can understand my concerns in relation to this, especially given recent news events.

My family and neighbours and I were astounded to hear that they have been granted numerous licences previously and that we have never once been consulted or notified of their events by them or any other agent. As the closest neighbour to the club I have find it unbelievable that not once, either recently or in the past, have the owners, agents, managers or staff of this club attempted to inform us, or any other neighbour, of events that they will be holding, verbally or in writing, even though they know that we will be directly affected.

Again as this is a residential rural quiet country area, and I am a local village councillor licensing until 3 or 4 every weekend I feel is wholly inappropriate. Although they have indicated that these events will be held indoors, in reality the control of their guests exiting the premises in the past has caused the local residents great concern, noisy vehicles and revellers being amongst their complaints to me. The Eureka website is currently promoting dusk till dawn parties, although they are currently applying for a licence that runs till 3am, which appears to me to be somewhat anomalous.

Other concerns form residents have been fireworks repeatedly been set off late into the night, and i know that complaints have been made in relation to this. More recently my family members and I have also been very concerned about the noise coming form the club, with extremely raised and angry voices being heard, to the extent that they felt that hey had to leave where they were riding as they were concerned for their safety. Also the application has applied for a making music licence, again this and last year we were continually assailed with some sort of percussionist drummer noise coming form Eureka, and on a number of occasions screams of noise, again coming form the club, shouting at this person to be quiet.

Below I have listed, to my knowledge, the residents within 500m and 1km of the club and would again like to point out that they are on the side of the valley overlooking these properties. Fawkham manor private hospital being one of them, and also that not one of us has been consulted by the club over this or another matter.

Dear Jessica

It is with great concern that we have "found out" that Eureka Sun club have applied for an entertainments licence – we have not been consulted.

We wish to lodge our very strong objection to this being granted.

Our land is situated right opposite to Eureka; it is only separated by a very narrow road. Our main concern is for our horses who graze in this field during the year. During the summer they are in the fields 24 hours a day.

The noise generated by Eureka's "Party's" has been on many occasions horrendous, the most recent being an "open to the public", (even though it is supposed to be a private members club) custom car show on August the 12th. The noise was so great that our horses had to be taken out of the field and put in the

stables as they were absolutely petrified; in fact I had to sedate one of the horses as he would not calm down as the noises persisted through the day and night.

We are continually overlooked by naked people as there fence has fallen down and not been replaced. On one occasion I found two people asleep on our land, telling me they thought they were at a Eureka party! This field is situated very close to my brothers house who has young children this has caused concern with strangers on our land late at night especially with the recent news story regarding a missing child.

We are absolutely astonished to hear that Eureka have been granted numerous licences previously and that we have never once been consulted or notified of their events by them or any other agent. As the closest neighbour and land owners to the club I have find it unbelievable that not once, either recently or in the past, have the owners, agents, managers or staff of this club attempted to inform us of events that they will be holding, verbally or in writing, even though they know that we will be directly affected.

This is the a very quiet rural area and the fact that Eureka have requested a licence to party till 3am is absolutely unacceptable and extremely concerning. During one of their parties this year I was called by my brother to come and sedate my horse in the middle of the night as not only were fireworks going off for a very lengthy period and after midnight but there was a lot of very loud music being played. My horse was in a terrible state when I arrived and should a licence be granted I have serious cause concern regarding my horses.

Whilst I was clearing my fields (poo picking) one morning on a Sunday at 6am a drummer persisted in playing his drums that he loudly/proudly shouted about using the night before which went on a on till one of the other members shouted for him to stop! If they found it annoying imagine how I found it?

I have recently been subjected to having to listen to a very heated and angry/loud argument that occurred whilst I was ridding my horse in my school – I was so scared I had to abort my session.

The other concern I have is that when these parties have taken place glass bottles are thrown into the fields along with rubbish which is really dangerous especially if the horses are in the fields 24 hours.

Our concerns are that the granting of a licence will increase further the numbers of concerning incidents, more traffic along very very narrow roads, extreme stress to our horses and the threatened security to my brothers family and my elderly mother.

I hope you consider our objection

EUREKA NUDIST CLUB FAWKHAM LICENCING APPLICATION

I refer to the above and am given to understand that an application has been made for 3 days entertainment licence until 0300hrs and that the Club's website advertises 'dusk-til-dawn' parties for members and non-members. This is basically a 'Nightclub' use, whichever way you look at it.

I would submit that the Nudist Club does not have specific planning permission from the LPA as a 'Nightclub' therefore the licencing authority may not legally be in a position to grant a licence.

A 'Nightclub' is not embraced by the 'Use Classes Order' and is 'Sui Generis' that requires a specific planning permission. This has not been applied for and the licences should therefore be withheld.

Moreover, I understand in August a boisterous 'all night party' was held at the club [I was not in the neighbourhood that evening] which caused considerable noise and disturbance to neighbours until the early hours. Unreasonable behaviour is unacceptable and reason enough to refuse a 3-day licence for entertainment etc. Granting a entertainments licence for 3 days can only exacerbate the situation.

Parishioners Views

When the current planning applications for Eureka were discussed at the Parish Council meeting on 27 September 2012 the following comments were made that we feel are relevant to the licencing application:

- 1. It is alleged that there are some permanent residents on site. The Electoral Roll has been checked and it does not include the property Eureka. This implies that there are no registered electors residing at Eureka. This view has been presented to the Eureka planning consultant and it has been stated that there are no residents on site but a duty manager is commonly there overnight to supervise the guests' accommodation.
- 2. The Manor Lane road access is completely inadequate for the current vehicular activity to Eureka. The narrow lane is being vehicle eroded and disfigured. The traffic causes congestion.
- 3. Pedestrian access is via roads with no pedestrian provision. No public transport is available to the site.
- 4. The "Members Only" rules are not being respected
- 5. Creates considerable litter outside of the site. Evidenced by bottles and cans in the hedgerow on the roadside of Manor Lane.
- 6. Parties spill into local area with one report of two people sleeping in a residents paddock and another of a woman screaming and being assaulted by a male at 0230h. Police were called and came next morning.
- 7. Extravagant and very noisy firework displays take place in the early hours. This causes considerable difficulties with animals. Eureka representative admits that this has happened but they now follow the law after advice from the Police.
- 8. There is a long history of entertainments at this site. As far as the residents are aware this has been without an appropriate licence albeit some temporary licences have been obtained but the number and frequency is unknown.

Other Comment:

- 1. As a result of the Parish Council meeting, the Fawkham Parish Council requested a site meeting. This was accommodated on Friday 5 October but the management and / or directors did not make themselves available. A separate report is attached to this letter of that meeting. Where appropriate the details in the report should be considered as part of this submission.
- 2. During the site visit we observed what we believe are very very serious safety risks with the close proximity of the touring caravans to one another. Model Regulations for touring caravans state that the spacing should be 6m wall to wall. In many cases the actual spacing is estimated

to be less than 2 metres. A fire in one would unquestionably spread to many and would likely affect the static caravans. This could happen during the night with many caravans occupied and people asleep. The club house itself would also be under serious threat. It takes little imagination to visualise a free standing large propane bottle being knocked over by a smoker and severing the flexible rubber hose. Firework displays and dense woodland add further to this risk.

- 7. No person under 18 is admitted and this is generally interpreted as not under 21.
- 8. The original planning permission is dated 1974 according to the planning agent.
- 9. At the gate there is a notice with a list of charges. This includes a Non-Members charge. This does not align with the current licence application.
- 10. During the meeting the representatives took no notes and made few comments.
- 11. It is clear that there has been rampant contravention of planning requirements over a considerable period.
- 12. The safety and fire risk of the site is a very serious issue that needs addressing. The close spacing of the caravans, with large gas bottles, would mean that a fire in one could readily spread to all of them and the adjacent buildings and woodland. Model regulations state that there shall 6m spacing between the walls of adjacent caravans.
- 13. Fireworks. Giles said that they were aware of the law after complaints and police advice following a late firework display two years ago. He stated that they are now compliant but people may be confused with the golf club or other locations that continue to release fireworks late at night.
- 14. Outside the main gate there is considerable litter on the verge with a number of beer bottles, cans etc. being evident.
- 15. Although the main electric gate is elaborate and looks secure, there is easy pedestrian access around each end of the gateway. Such access may be uncontrolled.
- 16. The idea of a liaison committee was raised and we asked that the idea be passed to the management. The idea seemed to be received positively.

Copy of the text of email sent to all Parish Councillors following a site meeting to Eureka on 5 October 2012.

Dear All

SDC Councillor Faye Parkin and I visited the above site from 0930 until about 1030 today. The visit was in connection with the two current planning applications. We were accompanied by Anna Turner-Bee, Parish Cllr Paul Blacker's sister who represented Paul. We met Mark Batchelor the Planning agent who prepared the applications and Giles White who is a general helper to the Director Mike Davies. It is disappointing that no manager or director made themselves available to meet us.

Matters that were ascertained from the representatives and other observations that are relevant or concern to the applications are:

- 1. There are 38 touring caravans on site arranged around the perimeter of an open area that resembles a large car park in scale. These caravans were not connected to drainage but connected to containers in most cases. Many looked like they had been there a long time and the majority had no number plates. Ages and sizes varied but all were typical of a touring caravan. They were parked in close proximity to one another being generally say 2m apart with no adjacent space for parking etc. Some were probably as close as 1.5m. Giles said that there are normally 25 to 28 touring caravans on site and the large number seen today was due to the seasonal changeover. The caravans are mainly used at weekends and always by their owners, they are not let out for rental. There was stated to be 22 to 23 electric hook ups for the caravans. A number of the caravans had 47Kg free standing propane bottles alongside (this is a large size about 1.2m tall). This is indicative of the caravans being on site for long periods
- 2. There is stated to be no facility on site for caravan storage.
- 3. It was stated by Giles White that there is no residential use and no residents on site. It is normal for the duty manager to stay overnight but this is a rolling duty and no single manager person stays on site for more than a few days. The duty manager normally sleeps in one of the static caravans.
- 4. The Mobile Homes / Static caravans have their own discrete area which is quite confined and has an unprotected and unscreened 2000 litre propane tank in close proximity amongst them.
- 5. There is no mains drainage for the whole or any part of the site.
- 6. The sum total of accommodation types can sleep 90 people at two occupants per facility. Giles stated that invariably only two people use each facility so the number of 90 or more seems realistic. Accommodation units were verified to be made up of 12 Log Cabins, 8 Static Caravans, a Lodge (sleeps four) and 38 touring caravans on the day of the visit.

Fawkham Parish Council wishes to object to the above application because the scope and extent of the application is well beyond what we feel is reasonable or acceptable in the rural location that is occupied by the Eureka Naturist Club. The proposed licenced hours are excessive and music outside of the licenced site should not be audible after midnight on any day or at any time of year. Further, all activities associated with any licence that may be issued should terminate at midnight on any daya.

Fawkham Parish Council has five members. One of our Councillors has declared an interest and has not contributed to this letter. The consultation necessary to formulate our objection has been based on an exchange of emails and a draft letter. This approach has been necessary as we learnt about this application after our last meeting. The short notice of the closing date for comments makes this the only practical solution for presenting the Council's views.

Technical Aspects

We have read the applications and from an accuracy point of view comment as follows:

1. The description of the premises is as follows:

Please give a general description of the premises (please read guidance note1)

Naturat club with members, holding discos.

Members of the Fawkham Parish Council visited the site on 8 October in connection with a current planning application. We can verify that the activities at Eureka extend beyond the above description. There are 12 log cabins, a lodge and 8 static caravans permanently on site offering overnight accommodation for 44 people minimum. There is also a caravan parking area that when we visited had 38 caravans present that can afford sleeping for at least a further 76 people. None of this accommodation currently has planning permission.

- 2. In section "O" of the application it describes that the premises generally open at 1000h each day. This is difficult to understand when there is fixed overnight accommodation and a caravan park.
- 3. In section "P" it states:
- a) General all four licensing objectives (b,c,d,e) (please read guidance note 9)

Members only Club (over 21) CCTV in operation.

According to the Eureka website the site is open to Non Members. There is also a tariff at the main entrance that identifies a charge for non members. It is impractical for the site to operate under the terms of the information in the licence application unless non-members are excluded.

4. Reference this statement by the Applicant:




Google Earth shows that the distance to the nearest residential property is 310m and not 1Km as stated. There are several other houses within a radius of 350m. Fawkham Manor Hospital main building is 520m from the Applicant's clubhouse.

Local Parishioners are of the opinion that in recent years the music source has been outdoors for some events. There have been reports of the music being audible well away from the site on Valley Road.
