Minute Item 7 - Interaction between this Committee and the Health Liaison Board
(Economic and Community Development Advisory Committee – 18 June 2013)

The Head of Community Development reported that there had been a number of significant changes to local health services in recent years and these changes were wide-ranging and complex. The Health Liaison Board was designed to bring Members with an interest in local health services together to share their knowledge and experience.
