THE SEVENOAKS DISTRICT COUNCIL (OFF-STREET PARKING PLACES) AMENDMENT NO.4  
ORDER 2010

The District Council of Sevenoaks in exercise of the powers conferred upon them by sections 32, 35 and 124 and Schedule 9 to the Road Traffic Regulation Act 1984 and of all other powers them enabling in that behalf, and with the consent of the County Council of Kent, and after all consultation with the Chief Officer of Police, HEREBY MAKE THE FOLLOWING ORDER:

- (1) The Sevenoaks District Council (Off-Street Parking Places) Order 2010 shall have effect as though:
  - a) the Schedule hereto were substituted for the Schedule thereto in its entirety;
  - b) the following definition in Article 2 Definitions and Interpretations was amended to:
    - 2.31 “parking place” means a car park provided by the Council as listed in the Schedule to this Order, including any access road thereto from the public highway and shall include any delivery area provided for the purposes of loading or unloading;
  - c) the following definitions were added in Article 2 Definitions and Interpretations:
    - 2.50 “delivery area” means a signed area within a parking place provided to enable and facilitate loading and unloading in connection with deliveries to or collections from premises in the vicinity of the parking place;
    - 2.51 “loading or unloading” means undertaking the delivery or collection of heavy or bulky goods in respect to premises in the vicinity of the parking place such that this is carried out as part of a continuous process;
  - d) the following were added to Article 8 Penalty Charge:
    - 8.9 Any person who parks or leaves a vehicle in a parking place such that it is in contravention of the provisions of this Order and such that the vehicle remains parked in the parking place for up to one day (the first day ending at 24:00 hours), and should the vehicle not be removed from the parking place and should it remain in contravention of the provisions of this Order, it shall be deemed that a new contravention occurs for each day the vehicle remains parked (each day being from 00:00 hours to 24:00 hours) and a new Penalty Charge Notice may be issued in respect of the contravention for each day that the contravention occurs.
- (2) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

**APPENDIX B**

- (3) The Order shall come into operation on 1<sup>st</sup> April 2015 and may be cited as the Sevenoaks District Council (Off-Street Parking Places) Amendment No.4 Order 2010.
