Dear Mr Bracey,

Thank you for your letter of 12 November 2014. I am the owner of number 7 Victoria Road.

I appreciate that there are issues with parking on these little roads due to lack of vehicular spaces provided by the old Victorian houses but also due to the roads being in such close proximity to the high street.

The proposed change allow for one permit holder's vehicle to be parked on a driveway, rather than within the permitted area, which of course is good news. However, the area coloured yellow on your plan will mean that permit holders will be unable to park in that area. The current area coloured yellow is far larger than one car parking space. As you will appreciate it is already extremely difficult for residents to find a space in this vicinity.

I do not disagree with the proposed yellow line, however, the extent of the yellow line is disputed. I would be grateful if you could reconsider the area highlighted green. Allowing this area to remain as permit parking would mean that the owner of 23 can park on their own driveway but also only take away one parking space from the permit zone, allowing other residents to continue to park in the areas highlighted yellow.


