Vehicles parked on the corner of this junction rarely cause a major concern, however, vehicles parked in Ashcombe Drive, in the lane exiting to Hilders, do cause near misses as they force passing vehicles into the path of those who are turning into Ashcombe Drive. As vehicles frequently turn in at speed and include large numbers of courier vans throughout the day this situation needs to be avoided.

My concern is that if the proposal restricts parking in Hilders Lane to the point where more drivers park in Ashcombe Drive we will end up with a significant safety and obstruction issue

I am a resident of Ashcombe Drive and wish to comment on the proposal to yellow line the junction mentioned in the subject. Traffic actually parked on this junction may occasionally cause a hazard but generally this rarely causes any significant problem.

There is, however, the potential for a significant hazard should parking restrictions in Hilders Lane result in their residents parking in Ashcombe Drive. Currently, whenever cars park in Ashcombe Drive in the exit lane any car that is driving out of the road is forced onto the wrong side. Cars entering Ashcombe Drive frequently do so at speed, also many of those use that junction as a turning area.

When considering this proposal please consider the impact on cars entering and exiting Ashcombe Drive and particularly the consequences of reducing the parking in Hilders Lane.
