1	Presently, parking is being abused by London commuters and Sevenoaks workers who park all day there. It is also of considerable nuisance to residents of Holly Bush Close.	
2	I regularly use the recreational ground and it's becoming increasingly difficult to get a space.	
3	Access to participate in Hollybush activity is barred by high street workers parking all day

5	The Hollybush car park should be available for those wanting to use the recreation grounds various facilities. In the past year or so, the level of all day commuter parking has reached such a level that it has become difficult to find a parking space. I support the proposals to restrict parking to 4 hours as a means of achieving this.

10	My family and I use the facilities at Hollybush during the day 2-3 times a week and parking is extremely difficult and needs to be addressed. The main car park at Hollybush is generally full before 9am and it seems to be commuters and people working in the town centre that park there, making it difficult for those who wish to use the facilities there- usually those with children and who require the ability to park near by - to do so.
11	Users of park and cafe cannot get a space due to commuters and town workers (particularly since new m and s was opened).
12	I have found it increasingly difficult to park when using the recreational facilities due to commuters parking at Hollybush - I believe the restrictions will solve this problem
13	I use this car park when I visit the bowls club and park itself and find it very frustrating when there are no spaces due to town workers parking all day
14	Stop commuters using the parking stopping other people from parking
15	Always difficult for genuine park users (often with children) to park due to commuters/town centre workers parking all day

21	My support is conditional upon appropriate concessions for members of the Sevenoaks Bowling Club and opponents from other clubs. On match days, the 4 hour limitation is unlikely to be long enough and I suggest some form of permit and guest permit be introduced evidencing club membership or authorised visitor whereby parking is allowed for up to 6 hours.

23	By restricting the parking time to 4 hours you restrict the numbers parking, which keeps space free for those using area for recreation.

26	Hollybush Close is located within a conservation area and when first built in 1995 was not designed to accommodate on road parking within the Close itself. Driveways adjoining the Close provide off street parking for residents. It has been demonstrated that without parking controls the local area has become despoiled by motorists parking their cars for the whole day. The situation within Hollybush Close has become intolerable as safety and convenience entering and leaving our own properties has been compromised whilst service traffic such as delivery vehicles, Refuse Lorries etc are finding it increasing difficult to gain straightforward access. In our case, our gardener has been unable to cut our beech hedge and maintain our borders in over two years as there is commuter traffic parked against it every work day. I believe that Sevenoaks Council have worked hard over the years to make ample parking available to visitors to the Sevenoaks area. The only reason we have all day parking within the close is due to lack of parking controls and selfish individuals who are not prepared to pay for available parking. Whilst I sympathise with their plight I believe that residents within Sevenoaks pay a premium to be able to walk to the amenities that Sevenoaks has to offer. I think it unfair that someone living outside of Sevenoaks can dump their car for the day with no thought for the impact that their actions might have on the local community. If they wish to live outside Sevenoaks and wish to park within Sevenoaks they should pay the requisite parking rate and factor it into their cost of living when making their own lifestyle choice.

We members are entitled to park as we pay a huge annual rent to SENCIO: 4/4s are even using the wider disabled parking pays, which is grossly unreasonable. I alternatively request SDC to alternatively consider a reduced period of two repeat two hours which will solve the problem by allowing dog walkers sufficient time and also those using the cafe if the top carp park is full up- which sometimes happens.

Up until 18 months ago there was never a problem. We are coming up to membership renewal time and a high number of members are saying they will not be re-joining due to the parking. We hope you will listen to the voices of the members of Sevenoaks Indoor Bowls Club we have after all been here for 26 years, and hope to be there for a long time to come.

I bowl several times a week at different times and the presence of cars used by joggers have prevented me from being able to park and thus prevents me from filling my obligations to the Indoor Bowls Club.

Now I live away from the centre, but still commute to and work in Sevenoaks town centre, I find it near on impossible! I did have a parking permit for a year, but had to give it up because of the cost. I have since re-applied, and have been waiting for at least 6 months, if not longer just to move up a spot from number 16. When I ask the council for an update, they tell me I am not really 16th, but 21st as a company has applied for permits for their employees. I not only think this is unfair, but I was also lied to and kept a little hope that I would move nearer the top of the list a lot sooner than I am. I know there are lots of on street, unrestricted places to park on the outskirts of Sevenoaks, but why should the majority of workers who contribute to the town's economy and keep it flourishing have to walk 20-30 minutes to get to their workplace? And I also know from my experience of living in Sevenoaks, that having non residents take up the majority of unrestricted on street parking is incredibly frustrating and an insult to the people who pay to live here. Many of us have resorted to parking around Hollybush. I am not in the minority; there are at least 30 people who park around that area just so they can cut their walk into town by at least 10 minutes. I know this is incredibly frustrating for the owners of the park and the café, and also for visitors, but some days I feel like there is no choice and I know I am not alone. Now I see a sign that says there will now be restrictions in the car park, please can you tell me what on earth we are supposed to do when there is absolutely NO free parking within a reasonable walking distance from the city centre? I am perfectly h

charges are so dear that I will not be able to sustain this everyday. My Grandmother-in-law owns a terraced house with one parking space, which I thought would be perfect for me to use. But I am told that the car has to be registered in her name to have the permit, she is over 80 years old, doesn't drive and doesn't even have a car! Why, as a relative, can I not take advantage of this unused space - I am even willing to pay for it! Can the town council introduce workers permits whereby it allows us to stay in the long term car parks at a reduced fee? I find the whole situation absurd, frustrating, upsetting and completely ignored by the council. The people who come into the town everyday and contribute to the town's growth and economy are the people who get most ignored.

I am writing to you regarding the new regulations underway for Hollybush recreation ground. As part of the management team working at Gap inc. I write to you in annoyance, a maximum of four hours does not support the long hours my staff require to work. Nor should my staff have to pay to park within Sevenoaks, when a lot of my staff do use public transport already to travel to work and back.

I am concerned for the Gap store within Sevenoaks as already members of my team have already started job searching elsewhere as they cannot afford to work within Sevenoaks, furthermore, we may have to take further action with our store if we start losing staff due to this. I believe the council are not supporting any employment within the Sevenoaks region due to not facilitating anywhere for employees to park all day. The council should give permits for people to park at Hollybush for free which has been acceptable for the past few years that I have been working here. This has been no issue due to the fact Hollybush is not even located within the town centre proving to be an isolated place to park for not just Gap but other Sevenoaks employees. As a resident of Sevenoaks, I have also been frustrated with the new regulations put in place in all Sevenoaks parking areas and I ask the council to inform us loyal employees where we should park from now on if this regulation goes through.

Further to the recent notices which have been displayed in the Hollybush Lane area, we write to you in hope that you will be able to provide us with some alternative parking locations or information regarding permits. We understand that very soon the parking around this area will be unavailable or limited to 4 hours per stay. This is very concerning as we feel that we will be left with no free or reasonably priced parking areas. We are located on the High Street and the majority of our support staff use the public parking and earn in the region of £15,000-£20,000 pa. Many parking areas in the town are pay and display and as we are sure you can appreciate this can become very expensive when parking Monday-Friday, 8am-6pm. Although we understand Sevenoaks Council offers a parking permit waiting list, many members of our office are already waiting and have been for a year, and in some cases more. As some of our staff travel from other Counties to get to work, the use of public transport is not an option. We request that you consider our situation and provide us with an alternative to paying at least £3.00 per day; these spaces are limited leaving us with the risk of not being able to even find a space. We believe that there are simply not enough spaces for all of the High Street workers who also park at Hollybush which has added to our concern. The price of parking aside, we have noticed that if you arrive in Sevenoaks later than 8am there are not enough spaces for all of the High Street workers and therefore losing these spaces we fear that it will be impossible to park at all.

OFFICERS' COMMENTS/RECOMMENDATION

COMMENTS

The Hollybush Recreation Ground Car Parks and Access Roads are owned/maintained by Sevenoaks District Council. The absence of a traffic regulation order to control parking there makes them difficult to manage, and prevents the Council from effectively dealing with any parking contraventions that occur there, such as "out of bay" parking. The all-day parking that takes place there reduces parking space availability for users of the leisure facilities at the recreation ground.

The feedback received during the formal (statutory) consultation to the proposed Order falls into two broad categories, namely concerns from users of the leisure facilities about parking difficulties at the recreation ground car parks caused by joggers/walkers/commuters/local workers and concerns from local workers about parking difficulties in the town centre and the potential loss of a free, all-day parking facility. A number of the objections were from users of the bowling club, some of whom considered that the proposed 4 hour maximum stay should be reduced to prevent joggers and walkers from parking there.

The concerns raised about the shortage of long term parking in Sevenoaks town are acknowledged, and the resultant plight of local workers, particularly those on a lower wage, is recognised. In consideration of this, the all-day parking charge in the town has been frozen over the past two years, and all available options to provide a solution to the parking shortage are being explored.

However, in this case, there is arguably an overriding duty to protect parking for users of the leisure facilities at the recreation ground, including joggers/walkers. The 4 hour maximum stay reflected the views expressed by the majority of respondents (83%) to the informal consultation undertaken in January 2016, which in addition to users of the bowling club, included users of the sports pitches, tennis courts, children's playground and the lodge café.

RECOMMENDATION

It is recommended that the objections to The Sevenoaks District Council (Hollybush Recreation Ground and Council Offices, Sevenoaks) (Off-Street Parking Places) Order 2016 be set aside, the Order be made, as published, and the proposed parking controls contained within the Order be implemented.
