Subject: To approve the this Council's updated Severe Weather Emergency Protocol (SWEP) for Rough Sleepers

Details of Decision taken

The SWEP details this Council's updated procedures to ensure that anyone identified as sleeping rough during severe cold weather can be offered overnight accommodation during this period.

Reason for Decision

This Council is committed to supporting people who are rough sleeping within the District. The SWEP aims to ensure that people sleeping rough are not at risk of harm during periods of cold and severe weather. This Council recognises the need to have a SWEP in place to safeguard the wellbeing of those identified as sleeping rough during a period of severe weather, although the numbers rough sleepers in this District are consistently low.

The SWEP aims to work with partners to identify people rough sleeping during severe weather and enables the Housing Advice Team to engage with them to offer and provide overnight accommodation whilst the SWEP is activated. This also triggers further engagement to deliver long term housing solutions to reduce the risk of someone rough sleeping in the future through advice and support by the Housing Advice Team as part of this Council's housing and homelessness duty.
