On Street Waivers, Suspensions and Charges for using in Parking Bays

Details of Decision taken

To confirm arrangements for suspending parking bays, issuing waivers and charging for the use of parking pays for other purposes.

Reason for Decision

Under Agency arrangements with Kent County Council, Sevenoaks District Council manages on street parking bays.

From time to time the council receives requests for suspensions and waivers to:

- reserve access
- allow excavations
- depositing of items (including skips)
- give a parking concession, for example for contractors or removal companies

The council may erect suspension signs and place cones to indicate the suspension. It may also monitor and enforce vehicle that park contrary to the suspension.

The council makes a moderate \pm 30 administration charge for arranging for a suspension, there is also a \pm 10 charge per day per 6-metre length of bay.

Waivers cost £10 per vehicle per day.

Waivers are available for car parks for £10 a day and £5 a half day.

The Cabinet Portfolio Holder for Direct & Trading Services is asked to agree these arrangements, supplementary to the Portfolio Holder's decision PHD4 in May 2017.
