

- Delivered by the Sevenoaks District Local Strategic Partnership (LSP)
- Co-ordinated by SDC key agencies, voluntary, community and faith sector representatives
- LSP Sub-Groups: Community Safety Partnership and Supporting People into Employment Group
- 94% of actions in the Community Plan were delivered in the 2018/19 action plan
- Target of 85% set for new Plan

- Funds to support Community Plan priorities
- Launched Sept/Oct to commence 1st April
- Appraised by trained Officer and Member Panels
- 2019/20: 25 grants 2018/19: 24 grants
- Three year SLA for Citizens Advice funding
- Quarterly monitoring of agreed
 performance targets

Leisure activities

- Three leisure centres (Sevenoaks, Edenbridge & White Oak)
- Lullingstone Golf Course
 - All managed by Sencio Community Leisure on long term lease until 2029 (25 years)
- Council pays an annual management fee to Sencio
- Loan to Sencio for Sevenoaks gym improvements
- Proposal for new Leisure Centre in Swanley
- Future plans to update facilities at Edenbridge
- Advantage Card SDC subsidises a concession
 scheme (people on some benefits, students and over 65's)
- SDC Delivery of targeted community sports activities (archery, walks, rides)

Challenges:

- How to maintain the attractiveness of town centres as a destination and a place to live
- How to encourage a diversity of retail and leisure uses

Achievements:

- The letting of the upper part of 96 High Street, Sevenoaks to Second Floor Studios CIC as a 'meanwhile use'
- Working with the Sevenoaks Chamber of Commerce and their retailer forum and the Edenbridge Business Forum
- Promotion of small retailers through the national Small Business Saturday event

Area of responsibility - Tourism

The Council Plan recognises the importance of the Visitor Economy. 'Build on the District's thriving economy through the regeneration of our market towns, and by enhancing both the visitor and rural economies'.

- Continuing growth in visitor numbers and associated spend in the District
- Capacity of transport and individual attraction infrastructure
- Limited accommodation offer

Challenges:

- How to increase visitor numbers to the District without overwhelming existing attractions
- How to extend the 'dwell time' and associated spend from existing visitor numbers
- How to provide sufficient transport links to rural tourist attractions

Achievements:

- The establishment of a Visitor Economy Forum
- Working with partners in Sussex, Surrey and London Gatwick to promote West Kent
- The development of a Community Rail Partnership (CRP) for the railway line between Sevenoaks and Swanley.

Area of responsibility - West Kent Partnership

Our vision for West Kent is to sustain a dynamic and well-connected local economy, to ensure that West Kent remains a key location for business success and growth and that our local population has access to quality jobs and skills development.

- High land values and property prices creates a shortage of available development land
- Lack of investment in infrastructure and congestion on transport networks
- Full employment and the 'push/pull' of Landon

Challenges

- Remaining engaged with local business needs
- Consolidating the Partnership's role and broadening the sphere of influence to progress priorities and secure funding
- Increasing the productivity in West Kent

Achievements

- Secured West Kent Enterprise Adviser Network linking businesses with schools to inspire future workforce
- Delivering business support programme supporting starts ups and growth businesses across West Kent

Area of responsibility

The West Kent LEADER grant funding programme (2014-2020), was established to award £1.8 million funding for projects in West Kent which create jobs, help businesses and develop the rural economy.

- Dependent on qualifying projects being put forward by rural businesses
- The programme is due to end in 2020 and the final cut off for projects to be assessed and appraised is September 2019.

Future Challenges

 Identification of post Brexit funding streams for farmers, growers, foresters and rural businesses to help secure a sustainable future for rural West Kent

Achievements

- Payment of £828,698.02 to 27 rural businesses across West Kent.
 Further project claims to be paid of around £900,000 to a further 14 rural businesses across West Kent
- Completed projects funded in Sevenoaks, £439,716.52, include: St Clere and Montreal - forestry equipment; Westerham Brewery visitor facilities and shop; Chart Farm - food processing equipment; Chiddingstone Castle - Café, signage
