# Portfolio Holder Executive Decision Statement

# The Local Authority (Executive Arrangements) (Meetings and Access to Information) (England) Regulations 2012

Subject: Penshurst Almshouses

## Details of Decision taken

To provide £25,000 non-repayable funding to Penshurst Almshouses to carry out essential improvement works with the aim of protecting and preserving much-needed affordable housing for older people whilst also improving on-site facilities for current and future residents.

#### Reason for Decision

Built back in 1833 and managed by the Penshurst Almshouses charity, the scheme provides much-needed affordable housing for older people with a local connection to the Parish of Penshurst and Fordcombe. This provides a safe and secure living environment for residents and access to garden areas to encourage older residents to interact - thereby helping to avoid social exclusion and loneliness, which has been identified as a serious issue nationally.

Redevelopment and replacement of the residents' laundry room is required in order that a facility can continue to be effectively used. With the drying of laundry in flats creating significant moisture, and particularly in solid-walled properties, dampness can consequently occur. This can then have a direct effect on the health of older people and cause several immediate respiratory issues as well as, over the longer-term, reducing lung function and causing other chronic health conditions.

The District Council has recognised almshouses as an important type of affordable housing provision for older people in rural areas and, as such, has committed to supporting local almshouses charities in its latest Housing Strategy (Priority 2.20, p28). Backed by recent evidence, the Housing Strategy also acknowledges that the vast majority of older people would like to remain living independently and, again, the provision of grant would support that objective (Priority 3, p35).

Assisting to upgrade on-site facilities would support a number of housing and wider health outcomes, as set out in the District Council's Housing Strategy and Community Plan. This project would also support wider work across the public

sector aimed at reducing the need for hospital admissions and other acute health interventions.
