Subject: Margaret Hyde Almshouses Charity

Details of Decision taken

To provide £25,000 non-repayable funding to the Margaret Hyde Almshouses Charity to contribute to essential improvement works on a newly-vacant dwelling with the aim of protecting and preserving much-needed affordable housing for older people in one of the District's rural areas.

Reason for Decision

Built back in the 1750s and managed by the Margaret Hyde Almshouses Charity, this housing scheme (situated in the hamlet of Wellers Town on the outskirts of Chiddingstone Village) provides much-needed affordable housing for older people with a local connection to the Parish of Chiddingstone. This provides a safe and secure living environment for residents with access to a large communal garden area to encourage older residents to interact - thereby helping to avoid social exclusion and loneliness, which has been identified as a serious issue nationally.

A vacancy has arisen in the scheme and in order to ensure that future tenants are provided with safe and suitable accommodation, the property is in need of urgent modernisation.

The District Council has recognised almshouses as an important type of affordable housing provision for older people in rural areas and, as such, has committed to supporting local almshouses charities in its latest Housing Strategy (Priority 2.20, p28). Backed by recent evidence, the Housing Strategy also acknowledges that the vast majority of older people would like to remain living independently and, again, the provision of funding would support that objective (Priority 3, p35).

Bringing a much-need affordable property up to standard would support a number of housing and wider health outcomes, as set out in the District Council's Housing Strategy and Community Plan. This project would also support wider work across the public sector aimed at reducing the need for hospital admissions and other acute health interventions.
