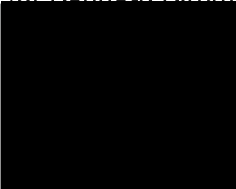

Annex 1 – Mandatory conditions

The supply of alcohol

- Where a premises licence authorises the supply of alcohol, the licence must include the following conditions:-

No supply of alcohol may be made under the premises licence -

(a) at a time where there is no designated premises supervisor in respect of the premises licence, or

(b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

- Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

Mandatory conditions in force from 28 May 2014

1. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

2. For the purposes of the condition set out in paragraph 1-

(a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979

(b) "permitted price" is the price found by applying the formula— $P= D + (D \times V)$

where -

(i) P is the permitted price,

(ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and

(iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;

(c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence -

(i) the holder of the premises licence,

(ii) the designated premises supervisor (if any) in respect of such a licence, or

(iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;

(d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and

(e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.

3. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.

4. - (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.

(2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

Mandatory Conditions in force from 01 October 2014

1.— (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.

(2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises—

(a) games or other activities which require or encourage, or are designed to require or encourage, individuals to—

(i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or

(ii) drink as much alcohol as possible (whether within a time limit or otherwise);

(b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;

(c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;

(d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;

(e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).

2. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.

3.— (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.

(2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.

(3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either—

(a) a holographic mark, or

(b)an ultraviolet feature.

4. The responsible person must ensure that—

(a)where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—

- (i)beer or cider: ½ pint;
- (ii)gin, rum, vodka or whisky: 25 ml or 35 ml; and
- (iii)still wine in a glass: 125 ml;

(b)these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and

(c)where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available."

Annex 3 – Conditions consistent with the Operating Schedule

1. Custom will not be sought by solicitation outside of the premises.
2. CCTV will be in operation and recording at the premises at all times that the premises are open to the public. All images will be retained for a period of not less than 30 days.
3. CCTV will cover the main trading area and entrance as a minimum.
4. A member of staff trained in the use of the CCTV system must be available at the premises at all times that the premises are open to the public.
5. Signage will be displayed advising customers that CCTV is in operation.
6. A log will be maintained of all incidents occurring at the premises, whether police were called or not.
7. Large, clear and bold signage will be displayed at the exit and in any outside area used by patrons requesting customers and staff to respect the neighbours and not cause unnecessary noise.
8. Outside areas used by patrons for any purpose will be closely monitored by staff to ensure there is no disturbance or anti-social behaviour.
9. All staff responsible for the sale of alcohol will receive training in all aspects of the requirements of the licensing act, such training will be documented and available for inspection by responsible authorities upon a reasonable request being made.
10. All staff will be trained in respect to Environmental Health Requirements.
11. Challenge 25 will be in operation at the premises at all times, clear signage will be displayed to advise all customers of it.
12. A refusals log will be kept and maintained at the premises of sale refused for any reason, ie age, drunkenness etc

13. Prevention and vigilance in illegal drug use at retail and unit area.
14. Bottles and other waste should not be removed from the premises and tipped into refuse and recycling bins between the hours of 21:00 and 08:00 . Waste and recycling bins utilised shall be lidded and large enough to hold all waste generated by the premises.
15. Hours for deliveries to and collections from the premises shall be between 08:00 to 20:00 Monday to Saturday and 09:00 and 17:00 on Sundays.
16. Signage used to advise patrons and staff to be quiet when leaving the premises shall be large, bold and clearly displayed for all patrons to see.
17. A log shall be maintained of all noise complaints received by the premises, and any inspections carried out in accordance with the running of the business or those required under statute. The Log book(s) will be available when requested by persons authorised under the Licensing Act 2003 or associated legislation.
18. Any doors and windows to the bar shall be kept shut after 20:00 with the exception of doors being opened to allow access and egress of patrons.
19. Customers temporarily leaving the premises e.g. to smoke ,shall not be permitted to take drinks or open glass containers with them.
20. Customers will be asked not to stand in the street talking, to a level which would cause nuisance to nearby residents.
21. Customers will not be permitted to remain on the premises beyond the opening hours.
22. Internal and external fixed lighting for Public safety.
