Sevenoaks District Council Statement of Community Involvement (SCI)

COVID-19 Review June 2020

The Statement of Community Involvement (SCI) is a statutory document which provides a guideline framework for development management and strategic planning consultations undertaken by the Council. The latest version of the SCI for Sevenoaks District was adopted in January 2020.

In light of the ongoing COVID-19 outbreak, Sevenoaks District Council may be unable to fully comply with the policies outlined in the January 2020 SCI. The Council is committed to effective consultation and communication with its residents, and in order to continue this, some consultation methods may have to change temporarily. This is to protect both our community and staff in line with Government advice and guidance.

The table below sets out which policies within this document have changed. It should be noted that the changes shown below, and in the track-change version of the SCI, are temporary amendments until such time as national social distancing measures are lifted, at which point we will revert back to the original January 2020 version of the SCI. The Council will continue to monitor the situation and will actively work to find new and innovative ways to consult at this challenging time.
