- 1. To make amendments to various sections of the Policy to clarify applicants' requirements relating to local connection criteria, exceptions, the Banding system, fraud investigations and data protection.
- 2. To add in additional information for reciprocal rehousing arrangements, in line with a new Kent Housing Group protocol.
- 3. To add in additional information to clarify Register applicant requirements for parents who have shared responsibility for dependent children.
- 4. To add further clarity on the evidence requirements for applicants claiming a local connect to give/receive essential care and support, through the close family connection.
- 5. To amend the documents required by each applicant, to improve the processes for the customer.
