Comments:I refer to the above application for a minor variation to vary this premises licence.

Amongst other things, the applicant proposes "to add following conditions recommended by the Environmental Health Authority".

However, the application appears to a typographical error and incorrectly transcribes the time that the EH Team recommended the connecting door between the restaurant and glazed seating area should be closed and locked: I suggested 22:00hours (but raised this as a point the Licensing Committee may wish to determine) but the application states 23:00 hours.

Provided this is a typo and the applicant is prepared to amend this matter, the EH Team has no objections to this minor variation. If this is not the case and the applicant has sought to amend the times we recommended, then we would object.
