Subject: use of S106 affordable housing contributions to secure Counsel's opinion

Details of Decision taken: approval to use S106 affordable housing contributions to secure Counsel's opinion

Reason for Decision

There are emerging concerns relating to development finance gaps arising on certain affordable housing schemes, notably 100% affordable and rural exception housing schemes, which jeopardise the delivery of new homes.

Independent viability testing demonstrates if a scheme is in deficit (ie where a development finance gap exists). A development finance gap renders a scheme unviable, meaning the scheme is unlikely to be developed and the new affordable housing will be lost. It has been ascertained a number of Kent local authorities use S106 affordable housing contributions to plug development finance gaps in order to secure delivery. Despite these helpful parallels, the District Council must ensure any use of S106 affordable housing contributions is in accordance with the parameters set in the Affordable Housing Supplementary Planning Document 2011.

It is therefore recommended we obtain Counsel's opinion on the principle of using Section 106 affordable housing contributions, where appropriate, to plug development finance gaps, specifically in relation to gaps arising on rural exceptions housing schemes and/or 100% affordable housing schemes. The advice provided by Counsel will help us defend any challenge or criticism if it were to arise.

Approval is sought to use S106 affordable housing contributions to fund the commission of Counsel. The cost of the commission will be shared equally between the District Council and our main delivery partners - WKHA and English Rural HA – at £1,000 each.
