- 1. In May 2021 we were asked by the Portfolio Holder to put a Health Action Plan in place and reinstate the HAT but to include Wellbeing, we had an initial meeting with partner organisations and developed the action plan. Due to us being approximately 2 months behind of the start date (April 2021) it was agreed that partners would work on this one through the meetings rather than wait for the following year as we had missed the Cabinet process.
- 2. Since that time, we have now developed a yearly action plan in collaboration with local partners. In December 2022 we held a workshop with partners to develop a new action plan against 4 priorities.
- 3. This plan has double the actions of the current one and has a lot of focus on mental health and issues around cost of living and health.
- 4. The plan is monitored on a quarterly basis by the Partnership, this report will update on action progress for Quarter 2 period (July-September 2023).
