Subject: Land East of High Street - engagement plan

Details of Decision taken: Approval to commence engagement and communication activity as part of plans by Sevenoaks District Council and Kent County Council to transform their assets to the east of the High Street in Sevenoaks town centre through a once-in-a-lifetime regeneration project.

Reason for Decision

Sevenoaks District Council and Kent Country Council are exploring how their property assets to the east of the High Street in Sevenoaks town centre, including a library, gallery and leisure centre, can help support a child and family-friendly, safe and sustainable thriving place for local businesses, shoppers, visitors, and residents both now and for the future.

An engagement plan is necessary to provide more information about the initial, early ideas, being developed by Sevenoaks District Council in partnership with Kent County Council.

The objective for this activity is to communicate the vision and initial concepts for changes to its facilities in the Sevenoaks town, the purpose of which is to encourage more people to visit and spend time in the town centre and the surrounding areas and to improve our public facilities.

The engagement plan sets out a series of events with key stakeholders and the wider public to gain insights and sentiment into how they use our assets and more specifically the early concepts.

There will be further opportunities for residents and stakeholders to engage and give their views on the project as it develops.

Choosing not to follow the engagement plan would reduce the value achieved from the agency.

No legal implications or risks arise from the proposal for an engagement plan. However, it should be noted that using existing insight and engaging with residents and stakeholders to understand what our communities need will shape the development and its implementation going forward. Further opportunities to engage will be embedded throughout the process. The overall proposals for our properties in this scheme will address potential future risks in relation to the maintenance of our assets and our ambitions to tackle the challenge of climate change.

A place based engagement approach seeks to have a positive impact by broadening the opportunities for communities to be engaged in the development of individual schemes, such as land east of the High Street. Engagement events will be held in an accessible venue, with alternative online provision available for those unable to attend in-person. The engagement plan seeks to gain the views from across our communities, with specific focus groups with representative groups and activities to encourage people of all ages to contribute their views. Anonymous data about protected characteristics will be collected through the online engagement survey and will inform the final report and be assessed in making decisions on the scheme.
